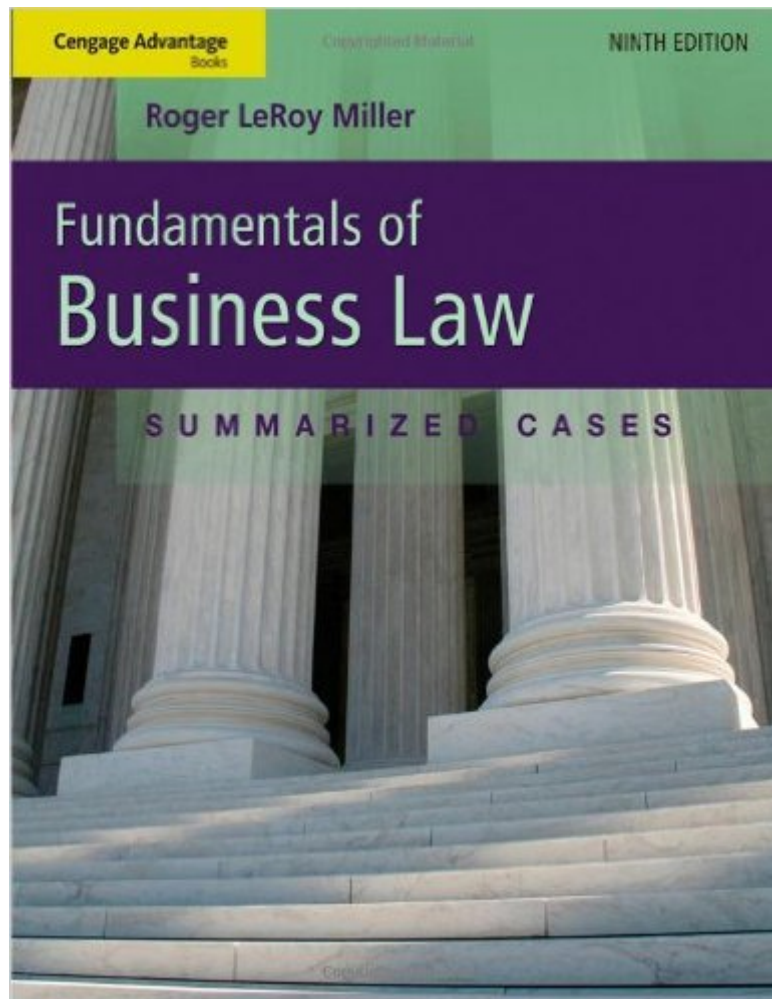

The book is straightforward and an easy read. It's not the most exciting book, but then again, I don't think many law books are. This is one of the best textbooks I've ever studied from. I don't think there's a single wasted word or sentence. Each concept is well laid out without unnecessary repetition usually found in textbooks.
