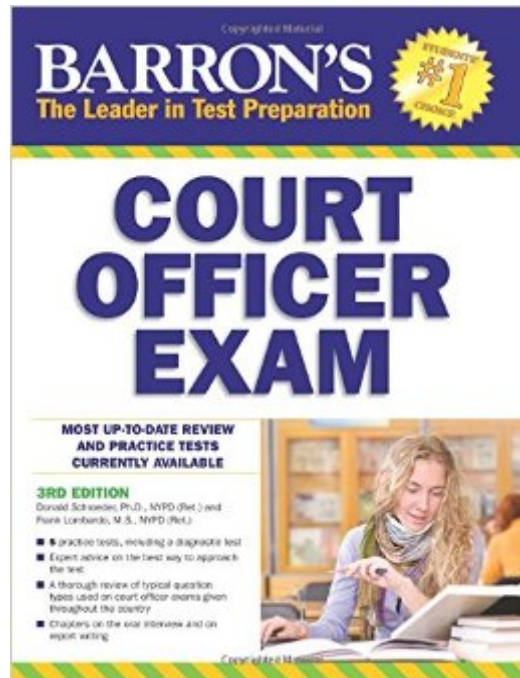

There are a lot of tips and pointers on how to study and what to look for in certain questions in order to get to the correct answer. If you fail an area on one of the exams it tells you what chapter you should study to have a better score in that specific area.
